## **Member's Room Rental Package Options**

### **Members Perk**

**(No Cost to Members)**

Suitable for Smaller Gatherings, Talks & Video TV Events

Package includes: Exclusive Use of Room. Tables, Chairs & TV,

(Waiting or cleaning staff are not included.)

### **Silver Rental Package**

**€150 + €100 Deposit**

Suitable for Smaller Parties, 21<sup>st</sup>, 40<sup>th</sup>, Communions, Christenings, etc

Package includes: Rental for One Afternoon or One Evening. Tables & Chairs.

(Waiting or cleaning staff are not included.)

### **Gold Rental Package**

**€500 + €100 Deposit**

Suitable for Small Weddings, Big Parties, Fund Raising Events, etc

Package includes: 1 Day Rental, 1/2 Strike Day. Tables, Chairs & Bar Access.

(Waiting or cleaning staff are not included.)

### **Platinum Rental Package**

**€1,200 + €100 Deposit**

Suitable for Larger Weddings, Major Parties, Major Fund Raising Events, etc

Package includes: 3 Day Rental, 1 Prep Day, 1 Event Day & 1 Strike Day. Tables, Chairs & Bar Access.

(Waiting or cleaning staff are not included.)

*Please Note: Maximum Capacity 100 Persons / Seating for 60 People*



## Rental Rules

1. The client must give the Club a reasonably accurate estimate of booking attendees no later than three (3) days in advance of the booking.
2. Access will be available on the first day of the Rental period as follows;
  - a. Gold & Platinum Package: Access from 1000hrs (prior by arrangement)
  - b. Silver Package: Access 3hrs prior to event start.
3. Event strike must be completed as follows;
  - a. Platinum Package: 1700hrs on the strike day
  - b. Gold Package: 1200hrs on the strike day
  - c. Silver Package: Immediately after the event
4. Cleaning;
  - a. SYC expect the client to leave the room and kitchen clean and ready for our next client to use. In order to comply with this, we strongly suggest that you use the Club's cleaner which will be charged separately.
  - b. Should SYC need to clean up after a client, SYC will charge €100 Charge. This amount will be deducted from the client's deposit.

## Terms & Conditions

- Club members will have unobstructed access to the Bar area of the club during normal opening hours
- The sponsoring member must ensure appropriate behaviour at all times by all attending the function and that all instructions of SYC bar staff and committee members are fully complied with by all attendees
- All alcohol consumed on the premises must be purchased through the bar.
- Alcohol will not be consumed by any person considered to be under the age of 18 without the required proof of age.
- Possession, sale and consumption of Illegal drugs is absolutely prohibited
- The premises are to be vacated at the agreed completion time (End Time) of the function
- The Visitor Book must be appropriately updated
- Access to the premises in advance of function to decorate or prepare the venue must be agreed beforehand and should in no way interfere with members' or other legitimate use of the premises
- Use of club equipment, catering utensils, crockery etc, is at the clubs discretion and subject to prior agreement
  - The use of tacks or sticky tape to attach decorations to walls is not permitted, Blu-tack only should be used
- There is a non-refundable charge for rental of the premises which will be advised when confirmation of the rental is agreed
